- TH area Light Study is almost complete. The Board is now waiting for final recommendations from the Engineering Consultant and we will start with electrical design so that we can secure electrical bids for the work.
- The 2nd RHA Board meeting in December (on the 28th) was cancelled due to the holidays
- Any 2020 RHA budget surplus will be split to 2021 Budget (50%) & RHA Reserve Funds (50%).

DID YOU KNOW...No exterior plastic covering is allowed on doors or windows.

DID YOU KNOW...Snow must be removed from sidewalks within 24 hours from end of snowfall.

The next RCI meeting is tentatively scheduled for February 10, 2021. Post cards will be sent with information closer to the date.



#### **Parking Committee**

The January Zoom meeting date is changed from Wednesday, January 20 (Inauguration Day), to Wednesday, January 13.

**Parking Decals:** Parking decals have been sent out to RHA Townhome Owners. Owners, expedite these decals to your renters as US Mail service has its issues this time of year.

- In addition, the decals must be placed on clear glass on your vehicle; and NOT on tinted or stained glass or windows.
- *Note*: Oram/Berger Pl. are 24-hr towing streets. An expired decal will get you towed.
- Please contact L&N (703-600-6000) if you have not received your decals. If you are a renter, call your landlord right away.

**Littering is Illegal!** Most people are unaware of littering fines. Section § 33.2-802. of the Code of Virginia makes littering or dumping trash a Class 1 misdemeanor, punishable by up to 12 months in jail and/or a fine up to \$2,500.

**Residents:** Junk mail is a nuisance. There are two ways to handle it. The right way & the wrong way.

The Wrong Way: taking your junk mail and leaving it on top of or on the ground below the TH cluster mail boxes. The wind and rain blows the mail around the common area and onto other home



owners property which is then labeled LITTERING.

The Right Way: Put it in the beautiful blue toters we have and place it out for recyclables or trash. Another option is to obtain from the junk mail the name and address of the issuer/distributer of this mail and have them remove your name from the mailing list -- I would definitely choose the Right Way; \$2,500 is a lot of money because I'm lazy!
