Key items addressed in Sept. by the RHA Board:

- New TH Parking Rules -- The newly approved Policy Resolution 2021-06 "Townhome Parking Regulations" became effective on September 13, 2021 and is being enforced. For example: anybody not authorized to park in your parking spot can be towed by calling Battlefield (see rule #16 in Section I of the regulation). The policy resolution was mailed to all TH owners, and can be found on the RHA website (with a bit of "clicking"), under Residents, Governing Laws and Documents, Resolutions, Policy Resolutions, 2021-06 Town Home Parking Regulations.
- Town Hall meeting -- The online meeting was held Sept 22, 2021, and discussed the May 24, 2021 memorandum received from Legal Counsel regarding: Concerns with Splitting the Association into Two Associations.

Architectural Control Committee:

At the last regularly scheduled meeting of the ACC, there was 1 application for a new fence in the detached homes. It was approved. The Committee set the October meeting date to TUESDAY, October 5 at 7:00.

DID YOU KNOW...In paragraph G.2.b of the Guidelines for townhome (TH) and detached home (DH), it states:

"Vegetable and herb gardens must only be planted in the rear (TH)/rear or side (DH) yard of a Lot. No vegetable or herb gardens of any type are permissible in the front yard of a Lot."

If you are planning on planting a fall vegetable garden or planning on planting next spring, do not plan on planting vegetables in the front yard. Vegetable gardens may be planted in the <u>REAR</u> or <u>REAR OR SIDE</u> (as explained previously) yard only.

DID YOU KNOW...When you have mowed your yard and you think you are done, you are not. You need to make sure the sidewalks are clean. You can sweep the grass clippings off the sidewalks, or you can "mow" the sidewalks. Make one pass pulling the mower, move the mower to the other side and make one pass pushing the mower. That should clean the sidewalk. Think of it as using your mower as a 4-wheeled leaf blower! It looks better and you're not dragging grass clippings into the house.



DID YOU KNOW...In the townhomes, bulk items to be placed out were some of the major points: for pickup cannot go out before Thursday evening. Currently, bulk items are scheduled to be picked up on Fridays, after the resident calls Bates no later than Thursday to schedule the bulk item pickup for that week. Also, it cannot be more than 3 items. These photos were taken on a Monday. This should only







look like this if the photos were taken LATE on a Thursday or EARLY on a Friday, and it should never look like the last photo; there are more than 3 items. Please be respectful of your neighbors and the community. Remember...we now have the ability to fine you for not following the rules. Neighbors are starting to

become very upset by things like this. Additionally, if the Board needs to hire an outside company to come in and remove the trash, they may consider passing the cost onto all townhome owners in the form of higher townhome owner assessments.

 RHA/LHA are currently working together to help the parking situations here within RHA and LHA for us all. Please read and respond to articles that are in the newsletter and correspondence which is mailed to you from the Associations.

- Parking space assignments within the RHA Townhomes have been completed. Reserved spaces with a painted lot number are assigned as "resident only"-- if you park there, you can be towed!
- In addition, all parking on Oram Place / Berger Place requires a valid RHA Decal 24hours a day.

"Lions and tigers and bears, oh my," warns Dorothy and friends in the classic movie The Wizard of Oz. And right here in RHA we have our very own danger mantra: "Bikers and pedestrians and cars, oh my!" For all, moving along newly paved and painted Parcher Ave. offers new opportunities and challenges as it curves its way through RHA.

First, for our many pedestrians -- shoppers, school walkers, workers, playmates -- who navigate "P-Avenue": There are now more marked crosswalks than ever before – to go along with the two in front of Hutchison Elementary are new ones at Saunders Dr. and near the pool, and three at Maleady Dr. Virginia law says anything on wheels must stop for pedestrians in crosswalks.


Secondly, let's look at the many motorized vehicles using Parcher -- cars, trucks, vans, buses, motorcycles. Gone is all that

extra wide space on Parcher between the pool and Saunders in RHA, thanks to those new bike lanes. Virginia transportation officials said it right: The tighter spaces likely cause drivers to go slower. But there are exceptions, like the impatient driver observed recently roaring across the double yellow lines past a car doing the 25mph speed limit near the school headed toward Centreville Rd.

And then there are those sparkling new bike lanes. They're springing up all over the DMV to encourage more cycling and less driving. Just like pedestrian traffic, cyclists have pedaled up and down Parcher for decades, headed to work, school and play. And now RHA's cyclists have dedicated lanes to more safely do so. Some tips:

- •Bike lanes are for bicycles only, not pedestrians, other two-wheelers or vehicles.
- •Always wear a helmet and ride in the same direction as the traffic flow.
- Obey all stop light and traffic signs, and yield to pedestrians.
- Signal when making turns.
- Pass other bikers with extreme caution.
- •Always watch out for motorists and other cyclists, especially near the dashed lines in bike lanes, where vehicles can turn right into cyclists' pathways.
- •Watch out for "door-ers," when drivers open their car doors into cyclists' path.

And there's one spot that calls for special caution: Bikes, walkers and cars must share the road space in the short span between the school crosswalk island and Saunders Dr. (Virginia law requires a **3-foot clearance** for a car to safely pass a bicycle -- if you can't man-



It's going to take some time and effort. But before long, the new RHA mantra is destined to become: "Bikers and pedestrians and cars, how wonderful!"



Update: RPPD in Detached Homes

by Don Nuss, RHA Board Vice President As of August 31, the Board of Directors completed its effort to collect signatures for the Residential Permit Parking District (RPPD). As of that date, residents from 52 of the 60 homes in the RPPD signed the petition, which was sent to the Fairfax County Board of Supervisors. The county will determine whether the petition meets their requirement for

an RPPD. If they determine it's OK, they will schedule a hearing to allow residents the chance to voice their opinions, negative or positive, of the proposed RPPD. Following the public hearing, the County's Board of Supervisors will vote to approve or deny the petition.

No Parking in Bus Stops & Bike Lanes: Fairfax Co. Code 82-1-6 prohibits parking in Bike Lanes, 82-5-28 prohibits parking in Bus Stops, and 82-5-1(4) prohibits parking within 15 feet of a Fire Hydrant. 
