RHA Board & Committee News:

At the Board of Directors meeting on April 11, the Directors discussed the following:

-- A new company, Haulin' Trash, will be responsible for trash and

recycling in the townhomes. Why are we changing companies? The current trash pickup contract was ending, so RHA evaluated 5 companies, including the present one, to determine the best value for the community. Haulin' Trash, a local company, was selected. A flyer was delivered to every townhome on April 22. Please refer to the Property Manager's article on page 3 or www.rha-homes.org for details on pick-up days and the phone number to call if you wish to schedule a large item pick up.

-- There will be new parking stickers in the townhomes. The stickers you currently have are good through June 30, 2022. Please refer to the article on page 3 for more details.

-- The recently damaged mailboxes on Fones Pl have been replaced with new ones and mail delivery has resumed. The old locks have been installed in the new mailboxes so there is no need

-- There will be a community-wide bulk item

pickup on Saturday, May 14. Please refer to the article on page 3.

-- The annual creek cleanup will be on May 21, from 8-12. Pizza will be provided after the event.

The Committee meets once a month on the first Monday (May 2 this month). If you wish to submit an application for change, please do so two to three weeks prior to the meeting so that any questions can be answered before the meeting.

DID YOU KNOW...When submitting a change application, ALL details should be included in the application's description. Please do not submit an application stating that you want to install windows like the ones in the brochure and that's all you write. If you want to change your windows, in the description you should state the material, the style, the color, and whether there are mullions (grids). "I want to install vinyl, double hung, white windows with mullions." That tells the ACC the material (vinyl), the style (double hung), the color (white), and whether there are mullions. If you also wish to include a brochure, you may do that **in addition** to the application.

DID YOU KNOW...The ACC had to deny approval of two change applications last month because all of the information for the requested changes was not included in the applications' descriptions. Please refer to the appropriate guidelines and include the information required for the change you're making.

DID YOU KNOW...Last month we wrote that the Board approved a change to the guidelines. You are now able to plant vegetables and herbs in your front yard **WITH THE FOLLOWING RESTRICTIONS**:

- -- Each vegetable or herb has a maximum height of 4 feet
- -- No part of any plant shall extend beyond the owner's yard
- -- After the growing season, plants must be removed.
- -- Failure to comply may result in an ACC violation/fine.

Recreation Committee, Inc. (RCI): by Gene Harper, RCI Treasurer The April 13 meeting was canceled. The committee will resume its business at its scheduled **May 11** virtual meeting at 7 p.m. For sign-in information, go to rha-homes.org or refer to the signin instructions on the March postcard mailing announcing the April and May meetings.

New pool furniture has arrived and will be in place on opening day, **May 28**, the start of the Memorial Day weekend.

Homeowners should have received the early April mailing from Sequoia Management containing three important items:

-- The first is the new **bright green hangtag** for RCI members to place on rearview mirrors of vehicles parked in the pool parking lot starting **May 1**.

-- The second is the cover letter and comprehensive **Parking Resolution 2022-1** that contains all the rules, regulations and conditions for parking vehicles in the pool parking lot. This document replaces the previous trial period resolution and instructions that were in place December 2021 through April 2022.

-- The third item is the **2022 Swimming Pool Application**. According to the application's cover letter, for quick action, applicants can go online by accessing the listed website URL or scan the QR code on their cell phones. They can also fill out by hand and mail the completed application. Once applications are received and processed, pool passes, required to gain access to the pool, will be mailed. Start the application process early to ensure you have those pool passes in hand by opening day.

New Townhome Trash and Recycle Days!

RHA has selected a new company, Haulin' Trash, to service the townhomes. Below are some frequently asked questions:

When will trash be collected? Trash will be collected *two times per*

week on MONDAY and THURSDAY. Our weekly trash service is for household trash only. Trash is recommended to be bagged, tied, and neatly placed in the designated trash container. Larger (bulk) items, hazardous materials, construction debris, inert waste (asphalt, sand, concrete, gravel, brick, etc.), tires, appliances, and items not accepted at the landfill will not be collected by the garbage trucks.

Please set your trash container out the night before collection, and stow your container as soon as possible after collection.

When will recycling be collected?

Recycling will be collected one time each week on THURSDAY. We use a single stream recycling system. Recyclables are collected and taken to a Materials Recovery Facility (MRF) to be sorted into various commodity streams. All acceptable recyclables should be mixed loosely and freely in the same container. Please "know your no's"! No Plastic Bags. No Glass. No Food Waste.

Please see the picture below of what is/is not accepted as recycling. When in doubt, place items in the trash container. Placing something in your trash does not mean it is destined to a landfill or dumped in an ocean. Fairfax county uses a Waste-to-Energy

IMPORTANT! program that burns all waste to reduce the amount of trash headed to a landfill, converts the resulting steam into electricity, and processes the ash to recover metal! When is bulk trash pick up? Haulin' Trash

Bulk collection is included in our weekly service but on an on-call and limited basis. All bulk items must be approved by Haulin' Trash prior to collection. All approved bulk items must be placed curbside and clear of any obstacles. Bulk items must be called, texted, or emailed into Haulin' Trash office and scheduled for collection. Drivers are not responsible for scheduling bulk pickup when/if they see large items set out for collection. This is the responsibility of the individual residents.

What is considered "Bulk trash"?

"Bulk" items are items that are too large for the trash container, are less than 50-lbs, and are not considered construction debris, inert waste, hazardous materials, tires, or appliances. Bulk items should be standard oversized household items such as a chair, couch, loveseat, mattress, desk, dresser, etc. Items such as pool tables, exercise equipment, hot tubs, basketball hoops, and trampolines are not included in bulk collection. Bulk items are limited to 1 -2 items per collection. Move-outs, evictions, demolitions, etc., are not approved items. Haulin' Trash has the right to refuse any item(s).

What if I have an item to dispose of that does not meet the rules for bulk collection?

Items not included in our weekly collection service can be collected by the junk removal department for an additional fee. Please contact Haulin' Trash at (703) 559-8558 or email sales@haulintrash.co (not .com) for a free, noobligation quote.

All appliances will incur a \$60 per-appliance fee. When is the yard waste pickup?

Because the townhome yards are so small, Fairfax County

does not require a separate pickup for yard waste. Your yard waste can simply be placed in your trash toter. Branches and limbs should be bundled together in lengths no longer than 4 feet and placed next to your trash toter.

Why are we changing companies?

The current trash pickup contract was ending, so RHA evaluated 5 companies, including the current company, to determine the best value for the community. Haulin' Trash, a local company was selected.

Why are we changing the number of days of pickup?

Many owners reported trash and recycle containers were constantly visible, and trucks were driving through the community 4 days a week. By observation, very few owners were taking advantage of the increased frequency of pickups. With the current schedule, trucks and trash/ containers will only be out twice a week.

Will I get a new trash/recycle toter?

Yes! All townhomes will get a new 64 gallon trash toter and a 32 gallon recycle bin. Trash bins have already been distributed. Recycle bins will be distributed later this month. What about the RHA marked trash toters and recycling bins?

You can continue to use these toters/bins. (continued on page 2b)

New Trash & Recycling Days (continued from page 2a) If you do not need them, you can repurpose, give to another neighbor, or discard with your other trash. The 64 Gallon toter is too big/bulky for my home. Can I get a smaller container?

Smaller containers will not be provided by the association; however, you can use your own container as long as it has a How can I contact Haulin' Trash to schedule a bulk hinged lid that closes to prevent trash from escaping or critters from getting in. If you opt to use your own container, please store your provided container in your backyard perhaps use it for storage. The next owner/renter will need the container. Owners are responsible for the replacement cost of any lost/stolen containers.

If I move can I take the trash/recycle toter with me? No. The toters remain the property of Haulin' Trash. If a toter is taken, you will be responsible for the full replacement cost.

Can I get an additional container?

Yes! Additional containers can be rented from Haulin' Trash for a one-time, non-refundable \$60 fee. All containers are owned by Haulin' Trash and must be returned at the end of service in a reasonable, used condition.

New (12-month) Townhome Parking Stickers coming in May Parking sticker expiration is



changing from 6 months to one year ... no more trying to resolve parking sticker issues during the holidays!

Please watch your mailboxes for the July 1, 2022 - June 30, 2023 parking sticker. We are mailing these out early enough to take into consideration the postal de-

lays occurring lately. Stickers may be affixed to a clear glass window (rear, front, side) of your vehicle upon receipt; however, do not remove the current sticker until it expires on July 1, 2022.

Owners are responsible for making sure their tenants have the new parking stickers in place prior to July 1, 2022. Owners, not tenants, are responsible to follow up with the management company with any parking sticker issues.

The association gives 30 days for owners to notify non-receipt of stickers. If you have not received the stickers by June 1, please email parking.dcmetro@fsresidential.com to notify the parking team at the management company, so alternate arrangements can be made for delivery of stickers.

If we do not hear from you by June 30 2022, we assume that owners/tenants have received the parking stickers.

The Association will not be held responsible for vehicles towed due to non-receipt of stickers, missing sticker, sticker not affixed in the appropriate manner, or if the sticker was not clearly visible on the window.

After June 30, 2022 the only way to receive a sticker is by filing a sticker re-issue form and paying a fee of \$25/sticker.

With the exception of Berger Place and Oram Place, all vehicles parked in our lots require parking stickers between 10:00 PM (evening) and 6:00 AM (morning). All vehicles parked on Berger Place or Oram Place require stickers 24 hours a day. As a reminder, please do not park along the yellow fire lines. Vehicles parked in the fire lane may be ticketed or towed.

We want to make sure you all have <u>Saturday, May 14</u> on your calendar! This is the day of the community-wide bulk item pickup provided by **Haulin**' **Trash** as part of RHA's trash collection contract! Let them take

away your **unwanted large furniture, applianc**es, rugs/carpets, tables/chairs, desks, etc.

We encourage you to place your bulky items out for collection no earlier than Friday afternoon.



HT will start pickups approximately 7:00 a.m., Saturday morning. <u>BUT</u>, there are some things HT will <u>NOT</u> pick up:

- -- liquids; combustible materials;
- -- tires; batteries
- -- dead animals;
- -- dirt; rocks;
- -- items identified as hazardous
- -- Construction materials including drywall, concrete, bricks

All townhome residents will receive one 64 gallon trash container and one 32 gallon recycle container. The new TH parking stickers for July 1, 2022 to June 30, 2023 are expected to arrive in mailboxes by the end of May. Unlike previous stickers, these stickers will be valid for 1 year. (Do not remove your current stickers until July 1.)
