The Board continues to receive complaints about the trash and large item dumping in the townhomes.

The Board has tried to fix this problem for MANY, MANY years. I have lived in this community since 1988; the problem existed then, and the Board was searching for ways to eliminate the problem then.

At one point, the number of trash pickup days was increased, but it made no difference. Trash and trash cans were out all the time and everywhere.

Currently, the TH trash pickup days are Monday and Thursday. Recycling day is Thursday. Still, there is trash out all the time, and there seems to be an increasing number of people dumping large items like furniture and white goods (washers, dryers, stoves, etc.).

This problem affects both townhome owners AND detached home owners. This is what is happening in the townhomes.

This is **YOUR** community. This

These are the 1H trash resolution rules:

- -- Trash days are Monday and Thursday.
- -- Recycling day is Thursday.
- -- Trash/recycling should be placed on **YOUR** property, in front of your own home, **NOT** on common ground.
- -- Trash/recycling should be placed for pickup no earlier than 7:00 p.m. the night before pickup day.
- -- Trash/recycling should be in the toters or bins issued by the trash company. NO loose plastic bags are allowed.
- -- Trash/recycling bins should be retrieved by 7:00 p.m. on Monday or Thursday (pickup day).
- -- Yard debris should be bundled, placed in paper bags, or placed in the toter.
- -- Large item trash is the responsibility of the homeowner and must be placed for pickup and removed from public view according to the same requirements as trash and recyclables. Large items are defined as: All items, including cardboard and delivery boxes, which will not fit into the trash cans, toters or receptacles described in the trash resolution. To arrange for a large-item pickup, call (703) 559-8558.

There are ways to report violators. Take a photo of them putting out the trash (or just the trash) and send the photo, the date of the infraction, and the violator's address to PM@rha-homes.org

The Committee normally meets once a month on the first Monday of the month. If you wish to submit an application for change, please do so 2-to-3 weeks prior to the meeting so that any questions can be cleared up before the meeting.

DID YOU KNOW...All sidings need to be free from stains that are usually the result of mold, mildew, algae, or moss. Additionally, gutters must be free from any noxious plant growth and debris.

DID YOU KNOW...In the townhomes, one pole bracket and pole is permitted per property



without ACC approval. Owners shall not place banner/flag poles in a location or manner so that such poles interfere with pedestrian traffic

on the public or common walks. In the detached homes, two flag/banner poles and brackets per lot on areas in public view are permitted without ACC approval.

This includes a permanent flagpole placed in the ground. Flagpoles require an ACC application that includes location, dimensions and construction details. Let's get those pole brackets up and American flags flying. It's the 4th of July. Let's CELEBRATE.

DID YOU KNOW...Collapsible canopies or tents shall not be left up overnight.


Time for bar-b-que, swimming, flowers in the yard and maybe some local outings. You may have noticed that the pool is open, and kids are out of school.

Foxes: Friends or Foes? by Gene Harper, RCI Treasurer

We've heard bad stuff about foxes in the metro DC area recently. The fox that killed about 25 flamingoes at the National Zoo in May and the one that attacked

or bit up to nine people on Capitol Hill in April come to mind.

Closer to home right here in RHA it's not unusual to see foxes. In fact our neighbors throughout western Fairfax County have posted multiple fox family sightings on social media apps, many showing frolicking cubs in backyards and woods.

But what about rabid foxes? They generally pose little threat to humans, their property or pets in Fairfax, according to officials. "Recent rabies cases involving foxes in Arlington and D.C. might cause concern for nearby neighbors," David Taube wrote in a May *FFXNow* news article. "But Fairfax has not seen any such incidents so far this year."

Our county had 11 reported cases of rabies, as of early May this year – 10 raccoons and one groundhog. And those are from 72 animals tested so far, said Bryant Bullock, county rabies manager. The county numbers only between 40 and 60 rabies cases a year, "with bumps in the spring, summer and end of the fall," Bullock noted. That breaks down into one-half of the cases from raccoons and one-third from foxes, raccoons and skunks. Plus there are a few cases in bats, cats, groundhogs and beavers.

Officials recommend you do not approach a fox acting aggressively or oddly. Call Fairfax County's non-emergency response line at 703-691-2131 and ask to have an animal control officer dispatched. Visit:

Foxes in urban areas commonly contract mange, a disease caused by mites that affects the skin and hair. Foxes with mange lose fur, have sores and frequently scratch and bite themselves. Fox mange can be contracted by dogs but generally is not a threat to other pets or humans.

Foxes are primarily nocturnal, but they are highly

adaptive and can become increasingly active during the day in urban areas. Large red foxes have been known, in some cases, to prey on small cats. Officials say



it's always advisable to feed pets indoors and to keep small pets inside or securely penned at night.

One RHA resident posted security-camera video of a fox carrying what could be a small animal in its jaws across his property one night. And a fox startled another RHA neighbor witnessing it running through a yard and hurdling over a 4-foot fence early one morning.

One county website notes that a fox's natural diet includes berries, plants, insects and small mammals. They also eat pet food, garbage, and bird feeder seeds. Foxes help control rodent populations by preying on rats and mice.

No Parking Within 10 feet of a Driveway: Per Fairfax County Code 82-5-1(a)(2). Measure it first, and then owners may call the Fairfax County Police Non-emergency Number, 703-691-2131, to report a vehicle too close to their driveway. Be sure to quote the violation code number shown above.

Recycling Rules: No Glass, No Plastic Bags, & No Styrofoam in recycling bins. The entire contents of the bin will be trashed.
