During the last few months, the Board, with the aid of Jonathan Stamps, our FSR property manager, has engaged with vendors on the drainage and erosion project and other efforts to improve the community's land. (see January 2024 newsletter).

Additionally, the Board is continuing work on bettering the lighting in the TH community. A couple of years ago, the Board initiated a light study that identified significant improvements were needed. FSR is seeking updated quotes from vendors to continue the effort and better the TH lighting, both RHA-owned lighting and Dominion Energyowned lights.

The full committee, along with FirstService Residential community manager Jonathan Stamps, convened Feb. 20 for an in-person and online session. Community members engaged in discussions about swim team management and budget matters until Stamps disengaged and redirected further discussion to the committee's executive session. One resident asking about how to become a committee member was instructed that members are appointed by the homeowner associations' boards of directors during annual meeting sessions.

Stamps reported that the transition from the former to current property management companies was still ongoing, with complete financial and other documents being uploaded to FSR's Connect portal soon.

Ginny Rodgers, committee chairperson, said that a poolhouse rental would occur on Feb. 24. This would be the first rental under a recently revised agreement and the first one since the 2020 COVID shutdown.

The pool season application process and pool passes will be 100 percent digital. Stay tuned for more details in March and April. ****************

<u>Street Ambassadors (SA)</u>: by Charlie Marts, Street Ambassador Chair Complaints about Neighbor's Activities?: As a quick reminder, if you believe that a neighbor's activities are violating the rules ("Covenants, Conditions and Restrictions", available on the RHA website), and have not been able to resolve the matter with your neighbor, we have a formal grievance process (Reflection Homes Association, Inc. Administrative Resolution 2021-5 Covenant and Rule Enforcement: Notice and Hearing Procedures). The Board does not take action on the basis of informal complaints made to individual Board members; we need a formal grievance. If the neighbor's activities are not violating the Declarations but are violating a county or state law, ordinance, or zoning, the appropriate source for resolution is the government agency in charge of enforcing the law, ordinance, or zoning. SAs promote community involvement by educating neighbors on RHA rules/events and providing your feedback to the board.



Mold Management

It's a problem man has battled since the dawn of time controlling mold. It lurks in the corners and can cause

major damage and nasty health issues. As long as moisture and oxygen are present, mold can grow indoors or out on virtually any organic substance, including wood, paper, carpet, insulation and food. When excessive moisture accumulates in buildings or on building materials, mold



growth will often occur, especially if the moisture problem remains undiscovered or unaddressed.

It is impossible to eliminate all mold and mold spores in the indoor environment. However, mold growth can be controlled by keeping moisture in check. Moisture control is key—mold cannot grow without it. Left untreated, mold gradually destroys the material on which it is growing.

Because molds produce allergens, irritants and toxins, they have the potential to cause a variety of health problems and can exacerbate existing conditions, such as asthma.

If mold is a problem in your home, clean up the mold and get rid of the excess water or moisture. If an area becomes water damaged, it is important to dry that space and any damaged items within 24-48 hours to prevent mold growth. Fix leaky plumbing or other sources of water to prevent recurrence. Wash mold off hard surfaces with detergent and water and dry completely.



Absorbent materials (such as ceiling tiles and carpet) that become moldy may have to be replaced.

Driving Rules Near School Buses

Reminder, Fairfax County Public Schools run more than 1,600 mph. Violations result in inbuses daily. We have been receiving multiple complaints about creased fines and DMV points. vehicles passing school buses after the bus stopped and the flashing red lights have been activated.

A lot of the violators appear to be high school aged kids driving to and from school. Please have a talk with your children about the dangers of passing a school bus that is actively loading/unloading children, and the possible legal consequences. Any passengers less than 18 years old, with certain exceptions, shall be secured in a safety restraint device.

Remember, passing a stopped school bus that has the lights activated is considered reckless driving. We will not issue warnings for these violations.

Remember, speed reduces your ability to react to pedestrians and bicyclists. The speed limit in active school zones is 25

Public Safety Update

Gas Leak vs. Unhappy Skunk

From the Fairfax County Fire & Rescue Department:

This time of year, the Fire & Rescue Department sees an increase in the number of calls for possible outdoor gas leaks. Skunks are breeding and deliver their young in 7-10 weeks. If a female skunk is courted by a male that she is displeased with she wards him off by spraying a strong-smelling liquid



(oil). The skunk's smell can be mistaken for a gas leak to the untrained nose. The most reliable sign of a natural gas leak is the smell, both Washington Gas and Columbia Gas add an odorant called mercaptan to create the distinctive smell of sulfur or rotten eggs. If you cannot tell the difference between the odors, listen for a hissing noise that gas under pressure would make when escaping a pipe. If you are still unable to tell if it's natural gas or a skunk, call 9-1-1 and the Fairfax County Fire & Rescue Department will respond and inexcerpted from the February 14, 2024 Newsletter of Dranesville vestigate.
